ATM / MasterCard Debit Cards

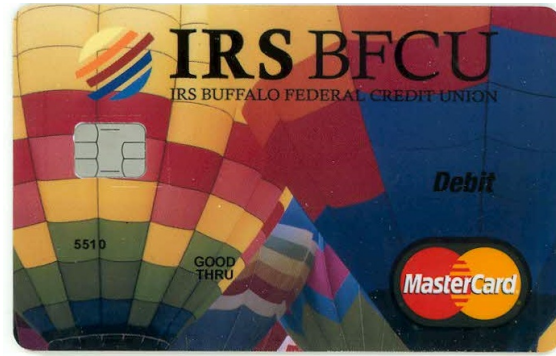
Just a few reminders:

1.) You can take money out of draft (checking) or share (savings) at any ATM. We allow 4 free PIN transactions per month. ATM operators may charge you fees they set.

2.) Only use your PIN if you are withdrawing money, it cuts into your purchase limit.

3.) If you have a draft account, many places will give you cash back with PIN purchases and not charge a fee.

4.) If you have a draft account, use your card like a charge card. They money must be in your draft, but you can transfer online, on the app or at an ATM anytime and it will be there in minutes.
